

**Mother's Day: NorthWest Shopping Centre gift with purchase promotion
Terms and Conditions**

Friday 23 April – Sunday 9 May 2021 or while stocks last

1. Information on how to claim and the offer form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions. Offer not valid in conjunction with any other offer.
2. The 'gift with purchase' is not valid to retail tenants in participating NorthWest Shopping Centre, their immediate family and staff of retail tenants within NorthWest. Immediate family means parents, siblings, spouse, children and grandparents. Tenants means Lessees, Licensees and in the case of a corporation, their directors.
3. The promotion commences at 9am Friday 23 April 2021 and claims close at 6.00pm on Sunday 9 May 2021 or while stocks last ("Promotional Period").
4. To be eligible, customers must spend \$200 or more in a cumulative total over 1 day at NorthWest Shopping Centre to receive a free 'Ashley & Co' 500ml Sootherup Hand & Body lotion, during the promotional period or while stocks last. Individuals must present their eligible retail purchase receipts to the value of \$200 or greater from cumulative transactions spent within the same day from participating NorthWest Shopping Centre retailers.
5. To claim a 'free gift', purchases must be made on the same day and redeemed on the same day at NorthWest customer service kiosk. Purchase receipts can only be used once. Only one (1) claim of a Gift is permitted per person per day during the Promotional Period
6. The first 1000 valid claims received will be eligible to receive a FREE 500ml 'Ashley & Co' Sootherup hand & body lotion. The Promoter reserves the right, at any time to end the promotion once the free gift stock has run out. The promoter will also attempt all efforts to remove advertising for this promotion immediately when the free gift stocks have ended.
7. Purchases made from Countdown NorthWest are not valid to claim the 'gift with purchase'. Any bank transactions, finance transactions, bill payments or purchases of gift cards, including NorthWest Shopping Centre gift cards, are also excluded from the 'gift with purchase' promotion.
8. Incomplete or illegible claims will be deemed invalid. If any receipt(s) used in connection with this promotion, are determined by the Promoter to have been obtained fraudulently or are a reprint of the original receipt(s), the Promoter has the right to invalidate a claimant's claim and the claimant will forfeit their right to a gift.
9. The Promoter reserves the right, at any time, to verify the validity of claims and claimants (including a claimant's identity, age and place of residence) and to disqualify any claimant who submits a claim that is not in accordance with these Terms and Conditions or who tampers with the claim process. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
10. Claimants must retain their original or a photocopy of their purchase receipt(s) for their claim as proof of purchase. Failure to produce the proof of purchase when requested may, in the absolute discretion of the Promoter, result in invalidation of the claimant's claim and forfeiture of any right to a gift.
11. If this promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law (a) to disqualify any claimant; or (b) subject to any written directions from a regulatory authority, to modify, suspend, terminate or cancel the promotion, as appropriate.
12. Except for any liability that cannot be excluded by law, the Promoter (including its officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Promotion, including, but not limited to, where arising out of the following: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any variation in gift value to that stated in these Terms and Conditions; (e) any tax liability incurred by a winner or claimant; or (f) use of the Gift.
13. The Promoter collects personal information in order to conduct the Promotion and may, for this purpose, disclose such information to third parties, including but not limited to agents, contractors, service providers, prize suppliers and, as required, to New Zealand regulatory authorities. Claims are conditional on providing this information. The Promoter may, for an indefinite period, unless otherwise advised, use the information for promotional, marketing, publicity, research and profiling purposes, including sending electronic messages or telephoning the claimant. Claimants should direct any request to access, update or correct information to the Promoter. All claims become the property of the Promoter.
