

**Passport to Flavour: NorthWest Shopping Centre Winter Restaurant Month promotion  
Terms and Conditions**

**Monday 16 August – Sunday 12 September 2021**

1. Information on how to claim and the offer form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions. Offer not valid in conjunction with any other offer.
2. The 'Passport to Flavour' promotion is not valid to retail tenants in participating NorthWest Shopping Centre, their immediate family, and staff of retail tenants within NorthWest. Immediate family means parents, siblings, spouse, children, and grandparents. Tenants means Lessees, Licensees and in the case of a corporation, their directors.
3. The promotion commences at 9am Monday, 16 August 2021 and claims close at 6.00pm on Sunday, 12 September 2021 ("Promotional Period").
4. To be eligible, customers must spend \$15 or more in one transaction across any 3 food and beverage tenant included on the 'Passport to Flavour' entry booklet at NorthWest Shopping Centre. The customer must receive a stamp from either the food and beverage retailer, or from customer services upon providing proof of purchase.
5. To go into the draw to win the \$1500 shopping spree prize, participants must return the completed 'Passport to flavour' entry form from their passport booklet with the 3 stamps to customer service kiosk before 6pm on 12 September 2021. Purchases must be made during the promotional period and entries outside of the promotional period will not be included in the final prize draw. Purchase receipts can only be used once.
6. Purchases made from Countdown NorthWest or food delivery services such as Uber Eats are not valid to claim purchases in the 'Passport to Flavour' promotion. Any bank transactions, bill payments or purchases of gift cards, including NorthWest Shopping Centre gift cards, are also excluded from the 'Passport to Flavour' promotion.
7. Incomplete or illegible claims will be deemed invalid. If any receipt(s) used in connection with this promotion, are determined by the Promoter to have been obtained fraudulently or are a reprint of the original receipt(s), the Promoter has the right to invalidate a claimant's claim and the claimant will forfeit their right to a gift.
8. The Promoter reserves the right, at any time, to verify the validity of claims and claimants (including a claimant's identity, age and place of residence) and to disqualify any claimant who submits a claim that is not in accordance with these Terms and Conditions or who tampers with the claim process. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
9. Claimants must retain their original or a photocopy of their purchase receipt(s) for their claim as proof of purchase. Failure to produce the proof of purchase when requested may, in the absolute discretion of the Promoter, result in invalidation of the claimant's claim and forfeiture of any right to be entered into the prize draw.
10. If this promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law (a) to disqualify any claimant; or (b) subject to any written directions from a regulatory authority, to modify, suspend, terminate or cancel the promotion, as appropriate.
11. Except for any liability that cannot be excluded by law, the Promoter (including its officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Promotion, including, but not limited to, where arising out of the following: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any variation in gift value to that stated in these Terms and Conditions; (e) any tax liability incurred by a winner or claimant; or (f) use of the Gift.
12. The Promoter collects personal information in order to conduct the Promotion and may, for this purpose, disclose such information to third parties, including but not limited to agents, contractors, service providers, prize suppliers and, as required, to New Zealand regulatory authorities. Claims are conditional on providing this information. The Promoter may, for an indefinite period, unless otherwise advised, use the information for promotional, marketing, publicity, research and profiling purposes, including sending electronic messages or telephoning the claimant.
