3. The promotion commences at **9am Monday, 25 July 2022 and will close by 6pm on Sunday 14 August 2022 (“Promotional Period”)**.

To be eligible for an entry, a customer must spend \$15 or more in one transaction at any NorthWest Shopping Centre café, restaurant or food court tenant during the promotional period (**9am Monday, 25 July 2022 and will close by 6pm on Sunday, 14 August 2022**) and present their receipt at Customer Services. Once the receipt is validated by Customer Services, customers must complete an entry form to go into the draw to win 1 of 50 x \$100 NorthWest Shopping Centre gift cards.
