

**NorthWest Shopping Centre Mother's Day 2024 "Win 1 of 10x \$5,000 Shopping Sprees"  
Terms and Conditions**

**Monday 15 April – Sunday 12 May 2024**

1. Information on how to claim and the offer form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions. Offer not valid in conjunction with any other offer.
2. The promotion commences at 9am Monday 15 April 2024 and closes at 6.00pm on Sunday 12 May 2024 ("Promotional Period").
3. To be eligible, customers must:
  - a) Spend \$25 or more in one transaction at NorthWest Shopping Centre during the promotional period
  - b) Complete an entry form from a participating retailer, at an entry barrel, or at Customer Service
  - c) Place completed entry form in an entry barrel located across the Centre
4. Each eligible transaction is only valid for one entry.

6. All prizes are not transferable, changeable, or redeemable for cash nor is it transferable/usable on any other services.

The winners will be the first valid entry randomly drawn from all eligible entries submitted during the Promotional Period. If an ineligible entry is drawn, or the Promoter is unable to contact a winner, having made reasonable attempts to do so, the Promoter may deem that winner's entry invalid and select a new winner on the same terms as the original Prize draw.
8. The winners will be contacted by phone on 13 May 2024, using the phone number details that are provided on the entry form. All prizes must be collected from the NorthWest Customer Service Kiosk.
9. Any Centre bank transactions, bill payments or financial transactions are excluded from entering the promotion.
10. Incomplete or illegible claims will be deemed invalid. If any receipt(s) used in connection with this promotion, are determined by the Promoter to have been obtained fraudulently or are a reprint of the original receipt(s), the Promoter has the right to invalidate a claimant's claim and the claimant will forfeit their right to enter the promotion.
11. The 'Spend and Win' entry is not valid to retail tenants or Centre Management staff at NorthWest Shopping Centre, their immediate family, and staff of retail tenants within NorthWest. The Promoter reserves the right, at any time, to verify the validity of claims and claimants (including a claimant's identity, age, and place of residence) and to disqualify any claimant who submits a claim that is not in accordance with these Terms and Conditions or who tampers with the claim process. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
13. Claimants must retain their original or a photocopy of their purchase receipt(s) for their claim as proof of purchase. Failure to produce the proof of purchase when requested may, in the absolute discretion of the Promoter, result in invalidation of the claimant's claim and forfeiture of any right to a gift.

If this promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law (a) to disqualify any claimant; or (b) subject to any written directions from a regulatory authority, to modify, suspend, terminate or cancel the promotion, as appropriate.
