

NorthWest Shopping Centre Winter gift with purchase promotion Terms and Conditions

Friday 1 August – Sunday 31 August 2025, or until stocks lasts.

1. Information on how to claim and the offer form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions. Offer not valid in conjunction with any other offer.
2. The promotion commences at 9am Friday, 1 August 2025 and claims close at 6.00pm on Sunday, 31 August 2025, or while stocks last (“Promotional Period”).
3. To be eligible, customers must spend \$120.00 or more in one transaction at NorthWest Shopping Centre to receive a free ‘Huski Tumbler’ during the promotional period or while stocks last. Excludes transactions from cafes, restaurants, the foodcourt, food and beverage, Woolworths, banking and finance stores.
4. Individuals must present their eligible retail purchase receipt (to the value of \$120 or greater in one transaction) to the staff at the NorthWest customer service kiosk on the same day and date of purchase. Purchase receipts can only be used once. If a customer has several different transaction receipts each more than \$120 from the same day shopping at different participating NorthWest retailers, they can only receive one ‘gift with purchase’ per customer per day.
5. The first 700 valid claims received before the promotional period close date will be eligible to receive a free ‘Huski Tumbler’ valued at \$29.99. There is one colour (Silver) available while stocks last.
6. The ‘gift with purchase’ is not valid to retail tenants in participating NorthWest Shopping Centre, their immediate family and staff of retail tenants within NorthWest. Immediate family means parents, siblings, spouse, children and grandparents. Tenants means Lessees, Licensees and in the case of a corporation, their directors.
7. Purchases made from Woolworths, restaurants, cafes, food and beverage, foodcourt, banks and finance are excluded from the ‘gift with purchase’ promotion.
8. Customers are required to fill in the entry form and have the participating receipt stamped by our team to claim their ‘gift with purchase’. Receipts must not be a duplicate.
9. Incomplete or illegible claims will be deemed invalid. If any receipt(s) used in connection with this promotion, are determined by the Promoter to have been obtained fraudulently or are a reprint of the original receipt(s), the Promoter has the right to invalidate a claimant’s claim and the claimant will forfeit their right to a gift. The Promoter reserves the right, at any time, to verify the validity of claims and claimants (including a claimant’s identity, age and place of residence) and to disqualify any claimant who submits a claim that is not in accordance with these Terms and Conditions or who tampers with the claim process. Errors and omissions may be accepted at the Promoter’s discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.

If this promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law (a) to disqualify any claimant; or (b) subject to any written directions from a regulatory authority, to modify, suspend, terminate or cancel the promotion, as appropriate. Except for any liability that cannot be excluded by law, the Promoter (including its officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Promotion, including, but not limited to, where arising out of the following: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter’s control); (b) any theft, unauthorised access or third party interference; (c) any claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any variation in gift value to that stated in these Terms and Conditions; (e) any tax liability incurred by a winner or claimant; or (f) use of the Gift.

The Promoter collects personal information in order to conduct the Promotion and may, for this purpose, disclose such information to third parties, including but not limited to agents, contractors, service providers, prize suppliers and, as required, to New Zealand regulatory authorities. Claims are conditional on providing this information.
