

NorthWest Shopping Centre (“Centre”) welcomes entries to the ‘**Black Friday Spinning Wheel**’ (the “Competition”). By entering this Competition, participants are deemed to have read, understood and accepted the following terms and conditions.

How to Enter

1. To enter, you must:
 - a) Spend \$50 or more in one transaction at NorthWest Shopping Centre during the promotional period.
 - b) Show your receipt to the team from NorthWest working at the Spinning Wheel where the team will sign the receipt as entered in the competition.
 - c) Take a spin to receive a random prize, or ‘better luck next time’.
2. Entry is only open to New Zealand residents, aged 16 years and over.
3. The Competition runs the following promotional period times, or while prizes last:
Thursday 27 November 12noon-2pm
Thursday 27 November 6pm-8pm
No entries will be received after this at the discretion of the Centre.
4. Each eligible purchase is only valid for one entry/spin of the wheel. Only one entry/spin may be submitted for each eligible person per promotional period. A purchase will only be deemed eligible if the receipt is kept. Failure to produce the proof of purchase when requested will forfeit any right to a Prize.
5. Receipts cannot be split for multiple spins.
6. The following stores are not eligible in this promotion (Ineligible Stores): banks, Woolworths, Lotto, ATMs, Bill payments, finance transactions. Retail Purchases made using a gift card or voucher are valid. Laybuy and Afterpay purchases can contribute to the total spend but will only be taken from the physical amount paid on the day, not total value of goods.

Prize

Other

14. These terms and conditions may be amended, and the Competition may be amended, varied, extended or discontinued at any time by the Promoter.
15. The Promoter’s decisions on all matters related to the Competition are final and no correspondence will be entered into.
16. The prize winner grants the Promoter permission to use their name and image in connection with the Competition and for future promotion and marketing purposes and waive any claims to royalty, right or remuneration for such use. This includes the right to use on the Promoter’s website, email newsletters, media and social media (including Facebook and Instagram or such other similar social media platform as the Centre chooses). The prize winner further consents to participate and co-operate as required in all promotional activities relating to the Competition and Prize including but not limited to being filmed and photographed during the redemption of the Prize for use by the

Centre, including on social media channels and any other promotional channels of the Centre, without any claim to compensation from the participant.

Standard Terms and Conditions

20. All entries are deemed received at the time of receipt by the Centre, and not at the time of transmission by the participant.
21. If a Prize or part of a Prize becomes unavailable for any reason whatsoever, the Promoter reserves, in its sole discretion, the right to either amend the Prize, including providing the prize winner with a substitute Prize, either in full or in part, at the same, higher or lesser value, or to cancel the Prize and/or the Competition in its entirety, at any time.
22. Late, misdirected, illegal, incomplete, or illegible entries are invalid. Only original, legitimate entries will be accepted. The Promoter is not responsible for any error, technical malfunction, loss, omission, communications delay or failure in relation to the entries.
23. Every participant warrants that all information submitted is true, correct and complete. The Promoter reserves the right to disqualify any participant who does not comply with these terms and conditions.
24. Employees (and such employees' immediate families, including an employee's spouse, defacto spouse, child, parent, or sibling) of the Centre, Stride Investment Management Limited, any Ineligible Stores, or any agency involved with the Competition, and the immediate families of such employees, and anyone not a resident of New Zealand at the time of the Prize draw, are not eligible to win the Prize.
25. The Promoter reserves the right, at any time, to verify the validity of entries and participants (including a participant's identity, age and place of residence).
26. The Promoter reserves the right to exclude any participant from participating in the Competition in its sole discretion, to the fullest extent permitted by the law. The Promoter reserves the right to refuse to award a Prize to a participant who is in breach of these terms and conditions, gained an unfair advantage in participating in the Competition or has won a Prize by using fraudulent or dishonest means, including but not limited to submitting false or misleading information. Errors and omissions may be accepted at the Promoter's sole discretion.
27. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
28. The Promoter's decision is final and no correspondence will be entered into.
29. The Promoter (including its officers, employees and agents) excludes all liability for any loss (including and without limitation any indirect, special or consequential loss), damage (including loss of opportunity) or personal injury suffered by any person in connection with the Competition or the Prize, including, but not limited to, where arising out of the following: (a) any technical difficulties, equipment malfunction or human error (whether or not within the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any entry that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Centre) due to any reason beyond the reasonable control of the Promoter; (d) any variation in Prize value or the Prize to that stated in these terms and conditions; (e) any tax liability incurred by a winner or claimant; or (f) use of the Prize, including any costs and expenses that may be incurred by the prize winner relating to the Prize or the prize winner's enjoyment of that Prize, except for any liability that cannot be excluded by law.
30. As a condition of participating in the promotion, the prize winner indemnifies the Promoter, all organisers, sponsors and all other persons and organisations associated in any way with the promotion against all claims, damages, liabilities, costs and expenses (including legal fees on a solicitor and client basis) which the prize winner may incur arising out of their participation in the promotion and/or using the Prize, howsoever caused.

In accordance with the Privacy Act 2020 by entering this Competition, participants agree that the Centre may collect, use, store and disclose personal information in accordance with the Centre's privacy policy. Failure to provide all requested personal information may result in the entry being invalid and disqualify a participant from being able to enter the Competition or receive a Prize. Under the Privacy Act 2020, participants have the right to access and correct any such personal information. Participants may access and request correction of any of the details about them held by the Centre by contacting the Centre directly.
