

The NorthWest Favourites February 2026 Competition

How to Enter

Other

19. If a Prize or part of a Prize becomes unavailable for any reason whatsoever, the Promoter reserves, in its sole discretion, the right to either amend the Prize, including providing the prize winner with a substitute Prize, either in full or in part, at the same, higher or lesser value, or to cancel the Prize and/or the Competition in its entirety, at any time.

20. Late, misdirected, illegal, incomplete or illegible entries are invalid. Only original, legitimate entries will be accepted. The Promoter is not responsible for any error, technical malfunction, loss, omission, communications delay or failure in relation to the entries.

21. Every participant warrant that all information submitted is true, correct and complete. The Promoter reserves the right to disqualify any participant who does not comply with these terms and conditions.

Employees (and such employees' immediate families, including an employee's spouse, defacto spouse, child, parent, or sibling) of the Centre, Stride Investment Management Limited, any Ineligible Stores, or any agency involved with the Competition, and the immediate families of such employees, and anyone not a resident of New Zealand at the time of the Prize draw, are not eligible to win the Prize.

23. The Promoter reserves the right, at any time, to verify the validity of entries and participants (including a participant's identity, age and place of residence).

24. The Promoter reserves the right to exclude any participant from participating in the Competition in its sole discretion, to the fullest extent permitted by the law. The Promoter reserves the right to refuse to award a Prize to a participant who is in breach of these terms and conditions, gained an unfair advantage in participating in the Competition or has won a Prize by using fraudulent or dishonest means, including but not limited to submitting false or misleading information. Errors and omissions may be accepted at the Promoter's sole discretion.
